## FLAG FOOTBALL WAIVER & RELEASE OF ALL CLAIMS

### IMPORTANT INFORMATION

The (District) continually strives to reduce such risks and insists that all participants follow safety rules and instructions that are designed to protect the participants' safety. However, participants and parents/guardians of minors registering for this program must recognize that there is an inherent risk of injury when choosing to participate in recreational activities.

You are solely responsible for determining if you or your minor child/ward are physically fit and/or adequately skilled for the activities contemplated by this agreement. It is always advisable, especially if the participant is pregnant, disabled in any way or recently suffered an illness, injury or impairment, to consult a physician before undertaking any physical activity. Personal protective equipment is strongly recommended, such as headgear, face guard, mouth piece, and elbow and knee pads.

### WARNING OF RISK

Flag football is intended to challenge and engage the physical, mental and emotional resources of each participant. However, despite careful and proper preparation, instruction, medical advice, conditioning and equipment, there is still a risk of serious injury. Understandably, not all hazards and dangers can be foreseen. Flag football is a limited-contact sport played with less personal protection equipment than tackle football. Certain risks and dangers include, but are not limited to, the acts of kicking, throwing, and receiving the ball, colliding with other players or stationary objects (both on and off the playing field), blocking or being blocked, falls, being hit by another player's elbow, running, jumping, stretching, sliding, diving, acts of God, inclement weather, poor officiating, inadequate or defective equipment, inadequate supervision, ruts/holes/depressions on playing fields, wet and muddy field conditions, incorrect footwear in poor weather conditions, unsportsmanlike conduct, illegal contact, and all other risks inherent to sport of football. In this regard, it must be recognized that it is impossible for the (District) to guarantee absolute safety.

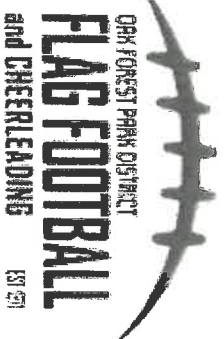
